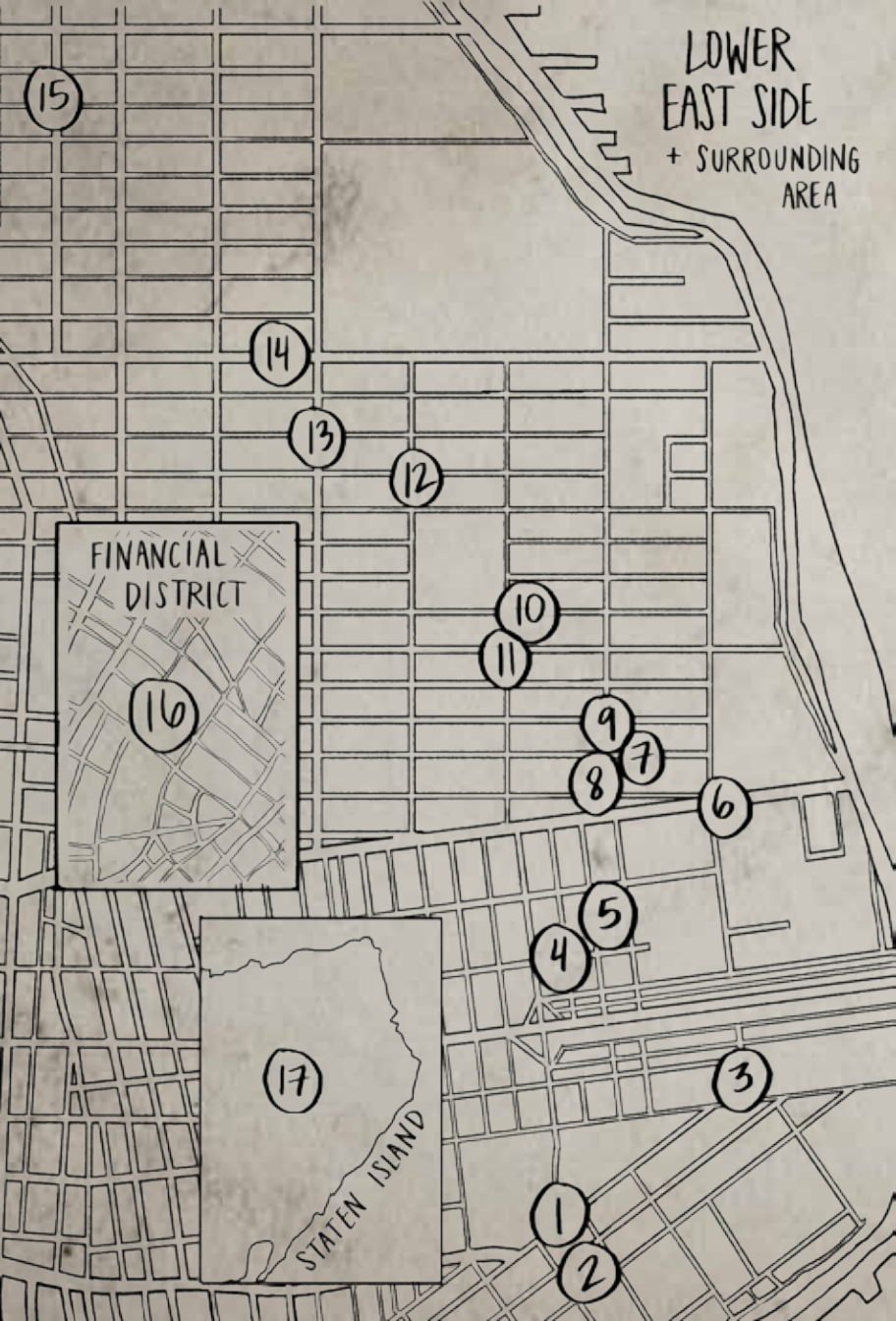

EARLY CHILDHOOD & YOUTH DEVELOPMENT PROGRAMS

From our pioneering Head Start early education programs to our eight Boys & Girls Clubhouses and college prep program, we've created evidence-based programming for young people in our neighborhood, ensuring that every young person has access to socio-emotional support and academic opportunities, regardless of the circumstances into which they are born.

Schools in the Lower East Side have graduation rates as low as 37%. For the ninth straight year, 100% of our College Prep participants have graduated high school and enrolled in college.

Her parents worked hard to make ends meet, which meant Karen had to care for her younger brother, ensuring he got to and from school safely, was fed, and finished his homework on time. These responsibilities left Karen feeling depressed, with little time to focus on her own future. Educational Alliance saw resilience and tenacity in Karen when she started coming to our Teen Center. She began by participating in drama classes with Educational Alliance before joining our college prep program. She is proud today to be attending her dream college and to be the first person in her family to pursue a degree.</p>

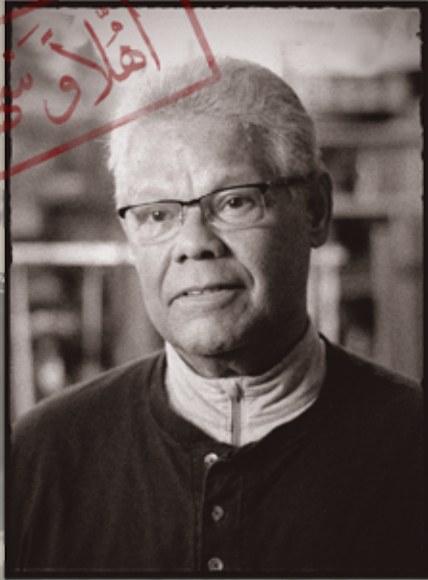
HEALTH & FITNESS PROGRAMS

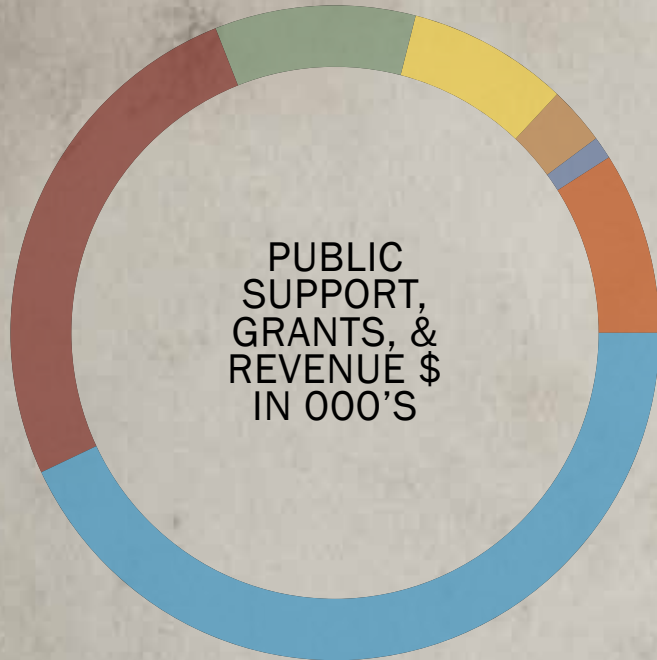

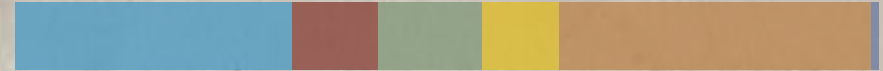
